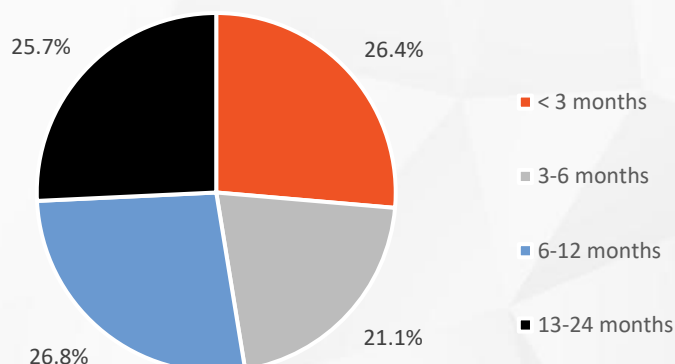

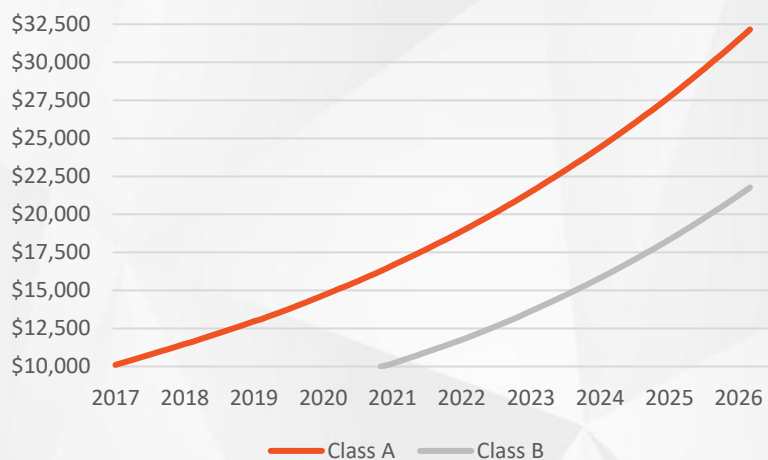

### NOTES
